SNEHA (Society for Nutrition, Education and Health Action) is a Mumbai-based non-profit organization dedicated to improving the health, nutrition, and safety of women and children living in vulnerable urban informal settlements. #### **COMPREHENSIVE OVERVIEW OF THE POSITION**

Specific areas of responsibility for research include designing the research, data collection tools to capture the program outcomes, conducting In-depth interviews, focus group discussions, transcriptions, analysis and coalesces of data emerging from qualitative research tools.
